GSA AWARDS FOUR HCATS CONTRACTS TO POWERTRAIN

Woman-owned small business awarded new GSA unrestricted Human Capital and Training Solutions (HCaTS) and HCaTS Small Business (HCaTS SB) 10.5-year contracts

Landover, Maryland, May 25, 2016 – Earlier this month, the United States General Services Administration in partnership with the Office of Personnel Management announced that PowerTrain, a woman-owned small business (WOSB), was awarded Human Capital and Training Solutions (HCaTS) and Human Capital and Training Solutions Small Business (HCaTS SB) Multiple Award, Indefinite-Delivery, Indefinite-Quantity (MA-IDIQ) contracts.

The solution includes two multiple-award, indefinite-delivery, indefinite-quantity (MA-IDIQ) task order contract vehicles with a \$11.5 billion ceiling. 72 unrestricted contracts were awarded under the HCaTS vehicle and 37 contracts were set aside specifically for small businesses under HCaTS SB.

HCaTS will provide tailored training and development, human capital strategy, and organizational performance improvement services to all federal agencies.

HCaTS includes two multiple-award, indefinite-delivery, and indefinite-quantity (MA-IDIQ) task order contract vehicles with an \$11.5 billion ceiling with a period of performance of 10.5 years (5-year base, one 5-year option period, and one 6-month option period).

A total of Eighty (80) firms submitted proposals for HCaTS (Solicitation Number [GS02Q15CRR0001](#)) and 95 firms submitted proposals for HCaTS SB (Solicitation Number [GS02Q15CRR0002](#)). PowerTrain was one of only three firms who received awards for both pools on each solicitation. The maximum dollar amount for each individual task order placed under an HCaTS (or HCaTS SB) contract is \$3.45 billion for Pool 1 and \$2.3 billion for Pool 2.

Opportunities through the new vehicle are anticipated in early FY 2017. Currently the acquisition is being reviewed by GSA and the Government Accountability Office.
